When to use this form

This form can be used to apply by persons applying for, or persons holding, a **liquor production and sales licence** who wish to share their premises, or a part of their premises, with another holder of a liquor production and sales licence. The part of the premises that is shared is referred to as a **collective outlet**.

Please note that a **collective outlet** must be granted over a **retail** or **wholesale outlet** for each of the licensees or as a **production outlet** for one licensee and as a **retail** or **wholesale outlet** for the other licensees. If you need to apply for a **retail**, **wholesale** or **production outlet** as part of this application, you will also need to complete the **Application for an Outlet** form, which can be requested by emailing liquorandgaming@sa.gov.au.

Collective outlets cannot be granted if the trade authorised at the premises would, in view of the number of licensees involved or the nature and extent of the trade or for any other reason, be better authorised by a packaged liquor sales licence or a licence of some other category.

This form can also be used for persons wishing to remove licensees from a collective outlet or change the outlet type connected to a collective outlet.
