## Details of the welfare concerns giving rise to the barring order

### Important information for the person barred

#### Offence

It is an offence to enter or remain on the licensed premises from which you have been barred during the specified period.

Maximum penalty: \$5000. Expiation fee: \$315

#### **Review of Barring Order**

You may apply to the Liquor and Gambling Commissioner for a review of the order if you are barred from a premises for a period exceeding 1 month, or for periods exceeding 1 month in total during a 3 month period. The Commissioner on review may confirm, vary or revoke the barring order. To review your barring order, please complete the *application to review a barring order* form located at cbs.sa.gov.au.

#### **Important information for licensee**

#### **Service**

This barring order does not operate until it is served on the barred person by:

- personal service
- leaving or posting it to the barred person's home address in an envelope addressed to the person
- posting it to the barred person's usual place of business in an envelope addressed to that person
- leaving or posting it to the barred person's solicitor in an envelope addressed to the solicitor.

A police officer may provide a licensee with information about a person (including photographic and other information) to assist with identifying the barred person.

#### Provision of this barring order to the Commissioner

If a person is barred for an indefinite period or a period <u>exceeding</u> 6 months, the order will cease to have effect unless, within 7 days of the service of the order, the Liquor and Gambling Commissioner (Commissioner) is provided with a copy of this order. Please also provide copies of any previous barring orders in relation to the barred person.

### Revoking a barring order

A licensee may, by a subsequent order served on a person, revoke a barring order.
