#### Liquor Licensing Act 1997

Report on Barring Orders 2009-10

30 September 2010

Hon. Minister for Consumer Affairs

I hereby present the first annual report on barring orders in accordance with section 128A of the *Liquor Licensing Act* 1997 (the Act).

On 1 March 2009 the *Statutes Amendment (Power to Bar) Act 2008* was proclaimed. The amendments to the Act enabled the Commissioner of Police and police officers of a specified rank to bar persons from a licensed premises or multiple licensed premises for specified periods.

Prior to these amendments, only licensees could bar a person from their own licensed premises. Unlike licensees, the Police have the power to bar people from all licensed premises, from all licensed premises in a particular area or all licensed premises of a particular class. The grounds of barring can be on:

- reasonable grounds based on criminal intelligence;
- welfare grounds;
- offences or offensive, disorderly behaviour on or adjacent to licensed premises; or
- other reasonable grounds

Previously, licensees may have been reluctant to issue barring orders, particularly to patrons who appeared to be linked to outlaw motorcycle gangs because of threats and intimidation. The new amendments will relieve licensees of these pressures.

Licensees may bar for a number of reasons including if they are satisfied that the welfare of a person is seriously at risk as a result of the consumption of alcohol. Licensees may also bar if a person who commits an offence or behaves in an offensive or disorderly manner on licensed premises or they may bar on any other reasonable ground.

A person who has not previously been barred can be barred by the licensee for up to 3 months or for a longer period approved by the Liquor and Gambling Commissioner. A person who has already been barred once may be barred by the licensee for up to 6 months or for a longer period approved by the Commissioner. A person who has been barred on at least two previous occasions can then be barred by a licensee for an indefinite or specified period.

A person in respect of whom a barring order has been made, may apply to the Commissioner for a review of the order, or apply to the Licensing Court for a review of an order by the Commissioner for an extended period.

The amendments have given the police and licensees greater powers to protect their staff, patrons and the premises from violence and other offensive behaviours, while also protecting vulnerable members of the community through the welfare barring provisions.
