

Licensee Barrings - Other

Report on Barring Orders 2012-13

Table 3 below details the types of conduct for which these licensee barrings were issued. Some barrings were issued for more than one reason. In 2012-13, licensees issued barrings for 146 types of conduct, compared with 114 in 2011-12.

Review of Orders conducted under section 128

There were 56 reviews of barring orders conducted in 2012-13 under section 128 of the Act, compared with 41 in 2011-12.

The Act requires a report on the number of barring orders reviewed regardless of the length of time for which the barring was issued.
