This report does not include barring orders issued by South Australia Police under sections 125A and 125B of the Act. These are reported by the Commissioner of Police in his annual report to the Minister for Police.

## LICENSEE BARRINGS - OTHER

## POLICE BARRINGS - CRIMINAL INTELLIGENCE

I have been advised by South Australia Police that no barring orders were issued on the grounds of 'criminal intelligence' during the period 1 July 2014 to 30 June 2015.

### REVIEW OF ORDERS CONDUCTED UNDER SECTION 128

There were 38 reviews of barring orders conducted in 2014-2015 under section 128 of the Act, compared with 31 in 2013-14.

The Act requires a report on the number of barring orders reviewed regardless of the length of time for which the barring was issued.
