I am pleased to submit my report on licensee barring orders for the period ending 30 June 2016 in accordance with the requirements of section 128A of the *Liquor Licensing Act 1997* (the Act).

Section 128A of the Act requires that I report on details of barring orders issued by licensees for an indefinite period or a period exceeding six months.

This report does not include barring orders issued by South Australia Police under sections 125A and 125B of the Act. These are reported by the Commissioner of Police in his annual report to the Minister for Police.

LICENSEE BARRINGS - WELFARE

LICENSEE BARRINGS - OTHER

REVIEW OF ORDERS CONDUCTED UNDER SECTION 128

There were 191 reviews of barring orders conducted in 2015-2016 under section 128 of the Act, compared with 38 in 2014-15.

The Act requires a report on the number of barring orders reviewed regardless of the length of time for which the barring was issued.
